Using resources efficiently in the rebound

Georg Fischer emerged strengthened from the economic crisis and capitalized fully on the global economic rebound in 2010. All three Corporate Groups posted double-digit growth and generated a significant operating profit. Sales in 2010 rose by 19 percent to CHF 3.45 billion. In local currencies, the increase was as much as 27 percent. Operating profit, too, was gratifying, with Georg Fischer reporting an EBIT margin of 5.2 percent. This uptrend is also reflected in the sustainability figures for 2010.

Ecology. Energy consumption and emissions rose on the whole by about the same percentage as sales in local currencies. Thanks to a raft of efficiency-boosting measures, total energy consumption – a good 6,300 terajoules – rose by only 21 percent, which was six percentage points less than sales. Water consumption and carbon dioxide emissions also rose proportionately less than sales.

The carbon dioxide and air emission data show that energy consumption – mainly in Asia – is shifting towards the use of electricity. Electric power is associated with higher air emissions particularly in the emerging markets.

The appreciable increase in waste subject to landfilling is not due to an increase in the waste produced by the manufacturing plants but to amendments to the laws governing such waste. This led to a major shift in waste classification particularly at two sites in Germany.

People. In 2010, headcount rose again by three percent to 12,908 people. In 2009, Georg Fischer made every effort to minimize job cuts affecting highly qualified personnel by introducing short-time work, training leave, use of holiday time and voluntary reductions in working hours. These measures were dropped in 2010 once sales picked up again, and further employees were hired.

In comparison with 2009, the fluctuation rate fell by almost a quarter, from 17 to 13 percent. While fluctuation has fallen, it is still

quite high, which is in particular due to the personnel cuts in 2009, some of which continued into 2010.

Investment on professional training of staff jumped back up to the 2008 level remarkably fast. 67 percent of employees participated in a training course outside their normal working environment in 2010 – that's almost a third more than the previous year. These employees invested some 25,500 working days in their training. In addition, employees participated in short-term training at the workplace, though this is not recorded separately.

The certification of all production plants to the occupational safety and health management system OHSAS 18001 continued in 2010. Ten large sites were certified for the first time, bringing the number to 21 of a total of 38 sites.

As part of its Corporate Social Responsibility efforts, Georg Fischer – through its Clean Water Foundation – contributes to providing clean drinking water for people in a number of countries. To date, the Foundation has donated six million Swiss francs to more than 80 projects in 40 countries, including India, Kenya and Ecuador in 2010.
